Hoe één burgemeester probeert heel Frankrijk te beschermen tegen gif

Geachte gemeente,- raadslid, ambtenaar en een ieder die dit onder ogen komt.

"Glyfosaat (roundup), het zijn geen vitamines. We willen er niets van. Maar we hebben het toch wel. Als je rookt, is het jouw beslissing maar je hebt niet het recht om mensen te vergiftigen. " <u>(1)</u>

Helaas voor vele onder ons heeft de rechtbank deze actie veroordeeld en rechtelijk ongeldig verklaart. Natuurlijk snap ik dat er wetten en regels zijn. Maar als deze wetten en regels niet ter bevordering van de volksgezondheid zijn, zijn het dan de juiste wetten? Voor mij is de boodschap erg duidelijk. De weg is dicht getimmerd om de burgers te beschermen tegen het gif.

Voor mij lijkt het erop dat je als gemeente ambtenaar je burgers niet mag of kan beschermen tegen het vergif dat deze en vele toekomstige generaties negatief zou gaan beinvloeden. Gelukkig gaat deze burgemeester de uitdaging aan en gaat in beroep.

Als zou blijken, uit wetenschappelijk onderzoeken die u bestudeerd heeft, dat een bepaalde toepassing onveilig is voor de bewoners van de gemeente wat zouden uw beslissingen dan zijn? Zou u uw kiezers met alles wat binnen en buiten uw macht ligt proberen te beschermen?

Het is vanzelfsprekend dat het bestuur wet- en regelgeving naleeft, juist als (mede-)wetgever. Integriteit betekent ook gewetensvol handelen. Wat dat voor de specifieke organisatie betekent, maakt het bestuur duidelijk in een integriteitbeleid. Goed bestuur gaat verder dan verkiezingen, vertegenwoordigende organen, het volgen van de juiste procedures en het handhaven van de wet. Goed bestuur gaat uit van persoonlijke integriteit bij het dienen van het belang van de burger.

De volgende tekst is afkomstig uit de petitie getekend door meer dan 18.000 mensen. (2) Deze tekst is geschreven uit een voor mij heel erg belangrijk perspectief waaruit wij als mensen kunnen leven. Naar mijn idee zou het goed zijn dat iedereen zijn best doet om hiervan uit te leven. Dat het mogelijk is dat we op deze manier invulling kunnen geven aan het dagelijks bestuur is voor mij geen vraag. Hierbij geldt wel, dit kan alleen als u er zelf voor kiest.

We staan voor een fundamentele keuze in het vormgeven van onze toekomst. Gaan we naar nog meer technologie en een steeds verdergaande robotisering van onze samenleving of kiezen we voor menselijke waarden zoals een verbinding met de natuur (herstellen), stilte/rust en authentieke connecties.

De keuzes uit ons hart.

Vrijwel alle moeders kiezen voor het laatste zoals ook een extreme meerderheid van alle vaders. We zien onze kinderen achter hun beeldschermen verdwijnen en ook zien we dat ze hier zelf ook niet gelukkiger van worden. Ze zijn verslaafd gemaakt en de massa wordt onverschillig.

Telecom heeft een steeds grotere vinger in de pap als het gaat om het vormgeven van onze toekomst. Het lijkt net alsof zij de enige speler is. Met slimme marketinghypes worden we keer op keer verleid om hun speeltjes te kopen en verleidt door miljarden knielt de overheid telkens door haar benen om het noodzakelijke netwerk hiervoor te faciliteren. Wat nu als we zeggen dat het genoeg is? Als we het draadloze sprookje niet langer als onze toekomst willen. We het zo meer dan voldoende vinden.

Dan zijn we niet de enigen. Inmiddels hebben 26 staten in de VS en vier kantons in Zwitserland, Genève en Florence de uitrol van 5G een halt toe geroepen.

Naast bovengenoemde ongewenste effecten, is ook het leven in de straling als die van een magnetron welke steeds harder aan gaat, niet wat we voor onze toekomst en leefomgeving wensen.

Op dit moment trekken meer dan 2000 wetenschappers aan de alarmbel betreffende door onze overheid genegeerde maar totaal onverantwoorde gezondheidseffecten van Elektro Magnetische Straling zoals van Wifi, Dect en zendmasten. Hierom willen wij een lagere stralingsnorm, eentje welke in Salzburg wordt aangehouden. Hierbij is draadloze techniek wel mogelijk, maar wel beperkter en dit zal anders moeten/mogen worden vormgegeven. Er zijn dan geen schadelijke stralingen meer en de techniek wordt schoon. Er komt dan een hart bij. Knappe koppen mogen deze aantrekkelijke toekomst nog gaan vormgeven en wij komen u graag helpen.

Durft u te kiezen of kijkt u weg?

Gaat Nederland haar eigen toekomst vormgeven, door het creëren van een leefomgeving dienend aan onze hoogste menselijke waarden, of laat ze dat ook in de toekomst door Telecom doen.

Wij stellen voor:

- Hanteren van een lagere blootstellings/stralingsnorm. (maximaal 10 microwatt per m2, de enige norm die de gezondheid respecteert). (3)
- Dat per direct gestopt wordt met verdere uitbreiding van een netwerk en er géén 5G komt, vóórdat de schadelijke (gezondheids-) effecten t/m 4G helder zijn en uitgebreid zijn geëvalueerd door onafhankelijken.
- Géén uitrol 5G.
- Eerlijke voorlichtingscampagne over de bestaande straling net zoals met roken is gebeurd en zoals ook de overheid van Cyprus verzorgt.
- veel meer aandacht en inzet op alternatieve communicatiemethoden welke de gezondheid en het welbevinden van de mens respecteren.

1.De vrijwillige toestemming van de proefpersoon is absoluut noodzakelijk Dit betekent dat betrokken persoon wettelijk bevoegd moet zijn om toestemming te geven; in staat moet zijn zijn of haar vrije keuze te maken zonder tussenkomst van enig geweld, fraude, misleiding, of enige andere vorm van beperking of dwang; en moet voldoende kennis en begrip hebben van het betreffende onderwerp zodat hij of zij in staat is een onderbouwde keuze te maken. Ik hoop dat ik met het volste vertrouwen mijn leven in uw handen kan leggen.



- Italy's Supreme Court upheld a lower court ruling that a businessman's brain tumor *was caused by cell phone radiation.*
- Businessman, Innocenzo Marcolini developed a brain tumor called a neuroma on the left side of his head.
- He had used a cell phone ~6 hours a day for 12 years.
 - The Italian Supreme Court relied heavily on Lennart Hardell's studies characterized as "independent" and "not co-financed by the same companies that produce mobile telephones".


In 2015 The General Exclusions section of their Canadian ProSurance Architects & Engineers Policy Document places EMF on the same footing as Asbestos: a total exclusion on liability for all EMF radiation.

i) Asbestos, or

ii) Any actual or alleged asbestos related injury or damage involving the use, presence, existence, detection, removal, elimination or avoidance of asbestos or exposure or potential exposure to asbestos.

The Exclusion stated in this Sub-section (n) shall not, however, encompass injury or damage involving products containing Asbestos where the existence of Asbestos is not in itself a direct or indirect cause of the injury or damage.
